Legality



Crimes Not Involving Touching

Crimes that do not involve touching or attempted touching typically prohibit solicitation or child pornography. South Carolina's solicitation statute is relatively broad, making it an offense for a person to communicate or attempt to communicate with a minor under the age of 18 for the purpose of persuading or coercing the minor to engage in sexual activity. For example, asking a minor to engage in sexual activity is a serious felony.

Likewise, photographing or videotaping minors engaged in sexual activity is an offense. The pictures must involve actual or simulated sexual activity; photographs involving nudity alone without sexual acts do not constitute child pornography under state law (though such images do potentially fall within the federal child pornography offense)

This is not legal in South Carolina, the state that 608/Carly lives in.

Note on Legality

608 continues to defend her actions through the use of a less official source.

She uses this when trying to explain:

Second-Degree Criminal Sexual Conduct With a Minor

Second-degree penalties apply when sexual penetration, intercourse, oral sex, or anal sex occurs between:

- a minor age 11 to 14 and a defendant of any age
- a minor age 14 or 15 and a defendant who's older than the minor or in a position of authority over the minor (familial, custodial, or official).

This offense level carries up to 20 years in prison.

When the parties are close in age—the victim is 14 or older and the defendant is 18 or younger—the penalties in this section don't apply. (More on "Romeo and Juliet" laws below.)

In reality, this website has got it wrong, as seen with what the .gov website has said. "18 or younger" is not stated within the official documentation.
